WHEREAS, the Board of the Captiva Erosion Prevention District of Lee County, Florida, on September 10, 2015 adopted Fiscal Year 2015/2016 Tentative Millage Rate following a public hearing as required by Florida Statute 200.065.

WHEREAS, the Board of the Captiva Erosion Prevention District of Lee County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Captiva Island, Lee County, Florida has been certified by the Lee County Property Appraiser to the Captiva Erosion Prevention District as \$1,304,227,824.

NOW, THEREFORE, BE IT RESOLVED by the governing Board of the Captiva Erosion Prevention District of Lee County, Florida, that:

- 1. The FY 2015/2016 tentative operating millage rate is 0.2901 which is no increase over the rolled-back rate of 0.2901.
