WHEREAS, the Captiva Erosion Prevent District ("District") on September 13, 2018 adopted Fiscal Year 2018/2019 Tentative Millage Rate following a public hearing as required by Florida Statute 200.065.

WHEREAS, the Board of the Captiva Erosion Prevention District of Lee County, Florida, held a public hearing as required by Florida Statute 200.065; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Captiva Island, Lee County, Florida has been certified by the Lee County Property Appraiser to the Captiva Erosion Prevention District as \$1,452,432,311.

NOW THEREFORE BE IT RESOLVED by the governing Board of the Captiva Erosion Prevention District of Lee County, Florida, that:

- 1. The FY 2018/2019 tentative operating millage rate is 0.2984 which is an increase of 0.0358 over the rolled back rate of 0.2626;
